WARRANTY AND RETURN POLICY

This warranty Policy covers any defects in material or workmanship under normal use and during the Warranty period.

During the Warranty Period, we will repair or replace, at no charge the parts that prove to be defective.

Warranty Period.

- i. The frame of the unit has a one-year warranty.
- ii. The bar of the unit has a one-year warranty
- iii. The engine of the unit has a six-month/100 usage hour* warranty against manufacturing defects.

Warranty for Damaged unit.

In the event any unit arrives damaged, purchaser agrees to save the box and contact Path-Maker to inform us of the damage within 5 days of arrival. We will handle the insurance claim at that point. If it's not brought to our attention within the time period, Path-Maker will no longer handle the claim.

Warranty conditions.

- i. The warranty for the bar of the unit will be void if it is not properly cared for, specifically, if it is run without oil.
- ii. Standard wear and tear are not covered under this warranty Policy.
- iii. No agent, distributor, or dealer is authorized to modify, adapt, or extend these warranty conditions.

Warranty claims.

All mentioned warranty periods are under the condition of access to the unit by our representative to verify possible non-conformance. Claims under warranty must be reported and returned to us within 20 days from the date of detection. This can be done on our webpage under the "Contact Us" section.

When a warranty claim is justified, shipping expenses have been insured by us.

As Is.

Any <u>used</u> units are sold as is. They are to be verified by us immediately before shipment that they are in working order, and at that point, they are shipped as is and sold as is. If they arrive damaged, you have the same time frame to report it as listed above, so that we may file an insurance claim. After that window has passed, there is nothing we will do.

Governing Law.

This policy shall be governed, construed and interpreted in accordance with the laws of the state of Louisiana.

Dispute Resolution.

In the event of a dispute between the parties regarding this policy, purchaser agrees that Path-Maker shall have the final say.

Changes to this Policy

We may change, review or modify our Return Policy any time from time to time without your consultation. We will post the updated Return Policy, and your continued use of this indicates your agreement with the reviewed Return Policy.

Returns.

Unopened and Unused units may be returned for a full refund minus a 25% restocking fee within 14 days. Buyer will pay return shipping. If the in unit is deemed to have been used upon inspection, the refund will be denied, and buyer shall be required to cover shipping of the unit back. Any used units may only be warrantied and or replaced as provided in this document. The refund will be processed and credited to the buyer within 5 business days of Path-Maker receiving the unit.
